HOMELESS BUT NOT HELPLESS
Startling, hopeful, hopeless, profound, surprising, sensitive, hard hitting..are some of the adjectives that best describe a new photography exhibition being held at the Carnegie Centre Gallery (3rd fl.), until November 15th.

This exhibition, entitled An Experiment in Power Pictures, takes photojournalism away from the stereotypical $\&$ into the realm of reality. This is street life by street people. Jody Bailey, Olivia Glendale, Stacey McMillan, Denise McMillan, David Morales \& Joanne Smith are 6 i"street youth" ranging in age from 14 to 22 who were unfamiliar with photography. They were given cameras $\&$ film $\&$ participated in a 10 -week long photography workshop conducted by photojournalist Robert Semeniuk under the guidance of John Turvey, who directs the Downtown Eastside Youth Activities Society \& North America's largest Needle Exchange progran.
There are eighteen $11^{\prime \prime} \times 14$ " photos, images of Vancouver street life \& death from the point of view of six young people who live there.

For new kids on the block, the gallery is side-by-side with Carnegie'e Learning Centre. One of many aspects $\&$ services is an English 11 class. Constance Brissenden, suggested to the learners in her class i: that they look at these photographs, then write down their thoughts \& feelings.
"It shows how unfair life can sometimes be. It makes me feel sad and mad at the same time. I'm sad because they weren't given a chance living in poverty; especially the children, who learn from the world around them. They see their parents as alcoholics, people lbeing abused. There isn't enough
moral support for going to school and, soon children are having babies, dropping out of school, becoming alcoholics or drug users, sometimes dying.
It makes me feel angry because of the 'giving up'. Even if you're poor, get a job; if you're ar alcoholic, go to AA; if you have personal problems from the past, see a counsellor. Don't give up. Try until you feel good about yourself and realise your goals."

"I saw those pictures. These are very different from what has happened in my life. They have no house so I don't know how they can survive. Outside is very cold but where would they sleep ...where would they make food??
In one picture a guy is bleeding"from his face but nobody is taking care of him. If I get hurt my parents worry about me and give me medicine. I am very sorrowful for these guys!'

"These pictures tell me some things. They give off feelings, I have some emotions, but it's funny... I'm not sure what. Some of the pictures make me sad, but others make me happy - like it's a wonderful world. I have opinions on what's shown, but inside my heart says get active and do something. This is important."

"1. One picture is of a baby, alive $\&$ full of hope. This makes people feel happy.

2. Another picture is of a dead person. He is so young. He lies in the coffin, just like he's sleeping. He doesn't know people around him are sad.
3. One picture is about a party. People are very happy and I feel happy too. 4. This picture is about two people dealing with drugs. They are killing themselves; they are committing crime.
4. Another picture is of two guys kissing each other. They may be homosexuals.
I feel these pictures show more sadness than happiness in this society."

" Each picture demonstrated or showed the value of life when living on the streets. To me each picture was an eye-opening experience because I've never been unfortunate enough to have to live (or make a living) on the streets. I've been lucky to
have someone to turn to but these people don't. From what I've heard, Social Services can be overwhelming; it might not be able to help.
People are dying everyday from drugs $\mathcal{G}$ gang fights. White cops hassle coloured people, so the nickname "pigs" is given to them. They seem to get a kick out of kicking these people around..it makes them feel big.
They've been moved or thrown out of a place they for some reason found comfort in, but once on the street can be hassled or hurt, even by those asked to help. It's obvious they can't help themselves but they just need a little hand. Some of the pictures show love even when there were difficult times." - Raj Gill
"Life is very precious.
There's a picture of a baby, not knowing what lays in the future.
There's a photo of a young guy that is in a coffin. How or why did he die? I feel so depressed. This is an everyday, routine lifestyle where street gangs are fighting each other over who sells drugs to these young children. to runaways, involving them in paying for drugs with their bodies.
Children run away from problems, such as an alcoholic parent. They couldn't find love at home and end up in deeper problems, by letting themselves get involved with pimps \& dealers. My solution would be to get out of the situation before it drags you down. It reminds me of a'poem I wrote:

## 'Life Style of the Unfortunate"

No way to live!
No way to live!
Is the outcry of our people.
Why are we poor?
We cry for our children,
We cry for our elders,
We cry for our homeless.
No one seems to care.

## CITIZEN'S GROUP PLAYS ROLE

Members of the Association for Vehicle Movement Safety are elated at their success in the defeat of socred Solicitor General Ivan Messmer in the election. While they admit that many forces likely contributed to his 3rd place finish (Jim Beatty (NDP) won) they stress that their efforts to educate votersi)about Messmer's failure to exercise public control \& accountability of his Ministry were well received. There were demonstrations in Messmer's constituency $\&$ hundreds of handbills were posted around the riding, detailing problems with the new Private Vehicle Inspection Program and 'roadblocks'.
"This proves that people are not as powerless in the exercise of government as some choose to believe," said spokesman Stuart Meade. "For 22 months they stonewalled our attempts to obtain the data proving the need for this program. All we've asked for is their demonstration of the need to force automobile owners to make repairs to seat covers, weather stripping, rust \& numerous other questionable items. It appeared lost on Messmer that, as our public rep, we are entitled to ask these questions of him. He just acted as an apologist for the bureaucracy," explained Meade.
The Association is calling for mandatory testing of vehicles for items that can be statistically justified $\&$ demonstrated to improve road safety. "Roadblocks have proven to be a very thorny issue. We see them both as a threat to our tradition of free movement \& public support of safety measures. Mandatory testing in govt. testing stations will remove this aspect of enforcement," said Meade.

# Human touch lightens litany of local squalor and 

 poverty among women, No Way to Live, which is now an assigned text in university courses across Canada.The other half of Under the Viaduct is more for the uninitiated - a deeply personal quest by a woman (Baxter) who found herself homeless as a child and again as a single mother with two daughters, and is now trying to figure out why.
ou get two books for the price of one when you take a trip Under the Viaduct with Sheila Baxter.
You get a concise reference work for housing activists, crammed with statistics and documentation on the problem of homelessness in B.C. and beyond. It is

Baxter is a fixture in Vancouver's lowincome Downtown Eastside as an unpaid advocate of the poor and a battler of bureaucracies. She's on welfare herself, and she knows her way around the mean streets of Main and Hastings, but she doesn't pretend to know it all. In fact, it's her wry and self-deprecating sense of humor that makes this litany of poverty, sexual abuse and mental illness so accessible to the ordinary reader.
In one instance, Baxter tries to interview the street nurses about housing for AIDS sufferers, but the nurses are so busy treating patients, she is stuck in a corner of the clinic for hours under a safe sex sign. "I figure it must look like this grandmother uses a helluva lot of condoms," she comments.

Later, she meets a guy who sleeps in his car. "He scratched the whole time I was interviewing him, so I didn't get too close. Book or not, I do have my limit."

She passes a bag lady every day on Main Street, a woman who lives in doorways and keeps all her possessions in plastic bags in a supermarket cart.
Baxter is too shy to approach the woman, so she pours out her feelings in a poem:
They tell me you choose
this life
that you prefer your aloneness.
When I'm home in bed, warm

The United Nations defines homelessness as not having security of tenure. By that definition, there are 10,000 homeless people living in hotels in the Downtown Eastside alone, many of them children.
Baxter lets the experts give the solutions. They all cost money. - for social housing, for higher welfare rates and minimum wage, as well as for a radical change of attitude in society.

A good way to start would be to make sure this compassionate book finds its way into the hands of those with the power to make those changes. $\diamond$

Thought I'd send a donation while I still have my big $\$ 400$ plus freelance cheque to pass around. Who knows, it might all get wasted on a political donation or something.

Reliable fossil evidence imprinted in the rock beds of this world tells us that cockroaches have been around for at least 350 million years. At that long-ago time, cockroaches were eightinch long flying insects which lived outdoors in warm climates.
Evolution caused them to adjust to a smaller size in order to survive and it robbed them of most of their powers of flight. However, if you catch an adult cockroach in your hand and then open your hand, you are likely to see that its kind still retain vestiges of the power of flight because that one in your hand is likely to spread its wings and whiz down to the floor like a landing helicopter.

We think of dinosaurs as creatures of antiquity, of ancient prehistoric time. But the cockroach saw the dinosaurs come, saw the dinosaur go, and was an ancient species when the human race came on the scene.

Cockroaches, in their enormously long history, have learned many tricks of survival.

Female cockroaches do not deposit a bunch of eggs and leave those eggs to chance. They lay their eggs in a sac which remains attached to their rear ends where the eggs hatch. At about the time of hatching, the female cockroach places this sac in some hidden spot and very soon perhaps 100 tiny white cockroaches emerge, every one of them ready for the task of foraging for food.

If you kill all the male cockroaches in a given location, the remaining females will continue to produce young in that way..but the young so produced will all be females, all genetically identical to the mother from which they came; clones, so to speak. When a male does come along, we may imagine, he will find a multitude of females available for breeding and the subsequent mixing of genes. Therefore we see that to kill off the male cockroaches only slows down the evolution of their race. It doesn't slow down their multiplication

Denied any other food, cockroaches will eat paint or rubber or soap or shit to stay alive. They will even eat each other quite as happily.

Surely most readers have observed that even in the most cockroach-infested living quarters, the insects are rarely if ever seen on, in or near the bed where the human sleeps. Persons who have observed this but who lack insight into the ways of cockroaches declare that this is because cockroaches do not like the smell ot human beings. That is not true. Cockroaches stay away from human beds because they have learned through the ages that to trespass there drives human beings into a fury against them and many cockroach deaths result from such incidents. Therefore, in a prudent spirit of self-preservation they stay away from human beds.
An entomologist is an expert on insects. In the above article, I have offcred Newsletter readers information that is well known to those entomologists. In the next issue, if the editor permits, I will offer information about cockroaches that the entomologists do not yet know. I think it is likely to be interesting to all

Tory Constitution will increase poverty
When you see the word "constitution" , do you: a) Blur out;
b) Think "that doesn't apply to me";
c) Groan;
d) Ask yourself "what are they up to now?"

I find that constituitional issues are the most complex I've ever tried to understand. Many people think that the constitution is about Quebec \& Aboriginal people \& their rights within Canada. It is. But, as usual with the Tory gov't., it's also about trying to change rules of our country to help rich people $\&$ corporations.
After studying the proposals \& reading the analysis distributed by the Action Canada Network \& by Claude Giraud of the National Anti-Poverty Organisation, I'd agree with Claude that the Tory constitutional proposals will "constitutionalise" poverty \& unemployment.
The govt's proposals are in 2 glossy documents: Shaping Canada's Future Together, \& Canadian Federalism \& Economic Union, Partnership for Prosperity.
Here are some ways that the govt's proposals will increase poverty:
Property Rights:
-The gov't wants property rights in the Charter of Rights \& Freedoms. According to an analysis of the Policy Alternatives "constitutional property rights would serve the interests of property owners, \& benefit mainly the minority of Canadians who own large amounts of property." Property rights can be used in ways that "exploit people, discriminate against them $\mathbb{G}$ harm the environment."
"Many laws have been created to protect. people from the exercise of property rights. These include laws related to collective bargaining, workers health \& safety, pay equity, employment standards (like minimum wages), division of marital property, landlord \& tenant relations, $\&$ consumer protection."
If property rights are put in the constitution, property owners will be able to challenge many laws that help poor people

- laws like rent control, minimum wage, pay equity. People who already have a lot of rights will have even more. Poor people will have less. It could also make it harder for: Native iPeople to claimitheir land, \& for govt. to regulate polluters. Changes to the Bank of Canada Act :
 to regulate money \& credit in the "best interest of the economic life of the nation." This means that the Bank is supposed to use its power over money to keep unemployment low.
The Tories want to change the purpose of the Bank of Canada. They don't want it to have any responsibility for employment, only for controlling inflation (the cost of living). This is very interesting because one of the main ways to keep inflation low is to keep unemployment high. The Bank can ( $\xi$ does) keep inflation low by keeping interest rates high, meaning that working people can't borrow money to buy things like washers $\&$ dryers, houses \& cars. It means that the people building these things get laid off because fewer are buying. That's how high interest rates create unemployment \& poverty.

Some economists say that the only way to keep inflation at zero would be to have a continually rising unemployment:rate: The rate is already a phenomenal $10 \%$.
The Tory changes to the Bank of Canada would ensure more poverty by telling it to keep inflation down (period). Since the main way of doing this is by keeping interest rates $q$ unemployment up, more people would be unemployed $\&$ poor.
The economic union:

- The $\bar{C}$ anadian $\overline{\text { Conentre }}$ for Policy Alternatives calls this section 'charter of rights' for big business. The Tories want the Constitution to forbid any "laws, programs or practices of the federal or provincial government that constitute barriers or restrictions...to the mobility of persons, capital, services \& goods.'
In a sense, this clause would make it unconstitutional for elected gov'ts to do even little things that help manage the economy in the interests of residents. It would make it harder for provincial gov'ts to create jobs, to promote small business, to properly create the kind of development that communities need.
Here are some examples: Quebec has a "Caisse do depot" that uses gov't pension money to help people who invest, create jobs $\&$ protect communities in Quebec. This is exactly the kind of institution provinces need to protect their residents from transnational corporations that have no loyalty to any country or region. But the "Caisse de depot" could be a barrier to trade under new constitutional proposals. $B C$ has public auto insurance which keeps jobs \& investment in $B C$. This could be a barrier to the free flow of private auto in surance companies to $B C$. The socreds recently decided to build a new ferry in BC. If these new constitutional proposals went through, the gov't would not be able to demand that the ferry be built in BC. They'd have to accept the lowest bidder, regardless of how many $B C$ residents would have to go on UI or welfare.
Hundreds of union jobs in the beer industry would be lost if this constitutional proposal goes through, because provinces
would not have the right to demand that beer companies produce in that province if they want to sell in that province. Could a good provincial health care program be considered a restriction to the flow of capital from profitmaking health care corporations from other provinces or the US?
The clause on the free flow of capital will make it illegal for elected gov'ts to use many powers they now have to create jobs \& reduce poverty.
Federal power:
The Tories want to give the federal gov't a new power to pass laws to provide for the "more efficient functioning of the economic union." These laws will have to have the support of 7 provinces with $50 \%$ of the population.
What would the purpose of this law be? It could be used against gov'ts like Ontario (NDP) which decided to have a deficit rather than slash people's programs during a recession. It could be used to force Ontario to reduce its deficit no matter how many people ended up on the street. It could be used to impose wage controls on workers, or to stop a provincial gov't wanting to tax the rich $\&$ take taxes off the poor.



If we ever elected an NDP or other federal gov't that wished to manage the economy to help people get decent jobs, this federal power would, again, make it hard for the gov't to act because it would need the consent of 7 provinces with $50 \%$ of the pop.
In short, the proposals would make it virtually unconstitutional for federal or provincial gov'ts to promote employment \& development, while making it easier for federal gov'ts to require policies that take from the poor $\&$ middle $\&$ give to the rich.
Housing, culture, labour market training, chīīcare:

- Theē proposals would give provinces more power in these areas of providing needed services to their own residents. And the federal gov't could abandon these areas. But all of these services cost a lot of money. The proposals would give provinces responsibility for programs that people think are important, but take away the provinces' rights to manage the economy to create the full employment \& taxes that pay for these services.

There is a lot more to understand in these Constitutional Proposals. The 28page CCPA analysis goes into the Distinct Society clause, the Notwithstanding Clause $\xi$ the impact of the proposals on Aboriginal Peoples.. \& other issues. If you would like a copy, call ELP at 879-1209.

safety and security committee this week for increased security.

Strathcona elementary is on East Pender and Seymour elementary is on Keefer, both east of the downtown core.
They want additional policing, more vice-principals and an updated phone system with emergency phones for staff and students. They've also requested increased fencing, afternoon needle and condom pickups, photo identification for all staff and volunteers, and training on how to handle intruders.
Sunrise area superintendent Alastair Fraser said the Vancouver school district's senior management team will look at the issue over the next two weeks and report back to the trustees.
"This is the reality of the innercity school area," Strathcona viceprincipal Kari Arnott said. "We need help."

Herron, who is in his fifth year at
Strathcona elementary, said students have found condoms and needles on the school grounds for several years. But last year a child found drugs in a small piece of plastic on the school grounds and took them home.
"That was the first indication we had (of drug dealing on school grounds)," Herron said.

Dealers go into the Strathcona school grounds, wrap a chunk of cocaine or other drug in plastic, bury it beside a fence post and go elsewhere to make the deal. The buyer is given directions to the drugs.

Strathcona staff find people "shooting up" drugs at all times of day on the school grounds. Two
weeks ago, a teacher discovered a prostitute and her customer having sex under an outside staircase at 4:30 p.m.
Staff call a special code over the public address system if an intruder enters. One elderly woman regularly wanders into the school and wishes anyone she meets "Happy New Year."

From her office window, Arnott looks out to the corner of Princess and East Pender, usually worked by a transvestite prostitute. "He must be in jail," she guessed from his absence Tuesday.

The administrators are dealing with unusual circumstances, but they're reluctant to discuss them.
"It could reflect on the school program," Arnott said. "People will say: 'Oh, I'm not going to send my child there.' "
As she and Herron walked through the school they proudly point out student art work and murals on every wall, a brightly colored dragon costume hanging in one hallway, the two computer labs, and the family room for parent discussion and craft groups.
dren laughed and chatted as they lined up. A Terry Fox Run banner attests to the school raising more than $\$ 4,000$ in pledges.

But there are also photos of a car that was blown up and burned in the school parking lot last year. Arnott and Herron tell stories of two rapes - not involving anyone from Strathcona - that took place on school property last year.

Besides academic, art and sports programs, the students are taught what needles and condoms look like, and what to do if they find one.

## $\overline{\text { AIDS }}:$ What It Is \& What It Isn't

What it is is deadly. If you are "HIV positive", you are a carrier \& can infect someone else. It isn't like a cold that can be passed on with a sneeze; it's not picked up from a toilet seat. The AIDS virus has to enter your body by way of a mixture of bodily fluids - through sexual contact with a carrier or using an unsterilised needle after an infected person has used it.

What it also is is terrifying. Health care professionals now take extreme precautions to ensure that blood or bodily discharges from patients do not come in direct contact with them. Paramedics, even police $\&$ security people, wear gloves when doing examinations or skin searches.

It can stop you cold.
Anyone knowing someone who has died from AIDS can describe the results of having all of a body's defenses rendered ineffective..to the point where you aren't able to fight off anything. The 'cure' for the common cold is to drink plenty of liquids, get a lot of rest, slow down, $\frac{G}{}$ in a week or so you're okay. AIDS completely strips you of your capacity to fight back: a cold becomes the flu becomes pneumonia becomes heart dysfunction becomes infection in the lungs/blood/brain \& you die. AIDS allows any breach of bodily integrity to run wild and, at the present time, once full-blown AIDS has developed out of being HIV positive it is invariably fatal.

It's pointless to go on about all the gory details. What needs to be examined are the reactions of governments $\&$ people of wealth, position $\&$ power. The painstaking research to find a cure for cancer has been going on for decades. Many observers wonder why, if so much time $\&$ energy $\&$ money has gone into curing cancer, no cure has been found. The cynicism is palpable in articles written on interviews with research scientists who state that various areas or avenues of research are actively discouraged, even closed, due to their not involving the product or field of the funding source. i.e. If a multinational oil
corporation wants The Cure to be derived from petrochemicals $\&$ the scientists feel it's a dead-end to pursue such research, the funding can $\&$ has been stopped. An artidle in the most recent Mother Jones dealt with exactly this point in an interview with a disaffected researcher in England. Another little tidbit: Directors of the Ford Motor Corporation, having before them statistical evidence that not installing an $\$ 11$ piece of equipment in a line of cars would result in over 200 traffic fatalities, chose to save the money.

AIDS has met with ingrained prejudice at senior levels of government (Vanderzalm while playing premier) \& warped special interest groups (REAL Women) because it has its largest dominance in socially unacceptable groups - homosexuals \& intravenous drug users. Note the media attenttion given to 'innocent' victims who, through no fault of their own (sic) died or are dying because of a tainted blood transfusion. .born to an infected parent. . a visit to the dentist. Behind the obstacles to acquiring adequate funding \& research facilities is this 'blame the victim' thing - IF you were pure in thought, word \& deed you wouldn't have AIDS - except for these 'innocent' victims.

It's highly that AIDS is a technological-ly-sourced scourge. Increases in all major diseases like cancer, diabetes, heart disorders, respiratory ailments $\&$ so on are directly attributable to our ever more distressed, processed \& chaotic society.

What we as individuals can do is follow basic precautions to ensure that AIDS does not become our personal executioner. Collectively, we can apply constant pressure on governments to tax fairly \& acquire sufficient funds. The most pressing thing is for all of us to increase our awareness, to make sure AIDS isn't just the first of technologically-spawned killers.

At the Town Hall Forum on Oct. 20, a need for straight answers seemed to be shared by all. The subject of the meeting - housing for people with mental illnesses - is the tip of broader $\mathcal{E}$, to some, deeper issues of safety, lack of support services, concentration leading to "ghettoisation", treatment at local hospitals or lack thereof, the mentally ill as victims, and so on. It's not my intent to dismiss other concerns with a casual 'and so on'; one of the main difficulties identified right at the beginning of the meeting was too many studies $\&$ reports. No one had a clear picture of what's here, only the knowledge that existing services are inadequate to meet the demand.

Marilyn Sarti is a courtworker for the Mental Patients Association. She sees people with mental illnesses daily $\xi_{\text {G }}$ her efforts to just refer them - for shelter, welfare, support \& counselling - has increased to 3 times what was required a few years ago.

The problems have increased with the closure of Riverview Hospital $\&$ the proposals for mental patient housing in the Downtown Eastside/Strathcona.

What is distressing to residents is the number of projects all coming here \& the intentional concentration in an area already bursting.

Marilyn was asked what are the basic needs that need to be met. She replied: 1. Acute care hospital beds - patients are óf ten rḗused admít $\bar{t}$ ance to hospital, mostly due to the chronic shortage of short-term beds.
2. Group homes - many more of these to provī̄e $\overline{\mathrm{t}} \overline{\mathrm{h}}{ }^{-}$kind of support needed but cutbacks in gov't funding have caused existing ones to close. Guidelines on operations (care component, rent..) are available but the same gov't that would fund staff also issues licenses.
3. Decentralise - stop the concentration $\overline{\text { q }}$ improve community integration of people with mental illnesses.
4. One-to-one support - rather than "warē̄ouse" people, decrease the ratio of staff to patients \& treat mentally $i 11$ as human beings.
5. Loosen up care restrictions - more
 ty interaction with $\&$ by patients.
6. Community input - ignorance $\&$ stereo typing máñàin fear; self-esteem for mental patients is often low, leading to victimisation $\&$ acting out.


Muggs Sigurgeirson, president of the Carnegie Association \& on the Strathcona Area Planning Council, said that basic info on numbers of people with mental illnesses, services available, mental health workers, even sources from which to get this stuff are just as confused now as 2 years ago.

All agreed that launching another study will only delay any progress in meeting immediate needs. What is scary is to provide mini-Riverviews in a tiny area $\&$ have vague assurances from government departments that everything is going to be okay.

It's not possible to do effective planning without adequate information; seeing mental patient housing increase in the face of this fact alarms many. The socred-inspired bureaucracy operates on the premise "What you don't know won't hurt you until it's too late for you to do anything about it."

What's necessary right now is contact with the fledging provincial NDP gov't \& requests for specific information on numbers $\&$ services...a start.

FEDERATED ANTI-POVERTY GROUPS
A while back there was a rally in Seattle when the reps from Canada \& the U.S. got together on the 72 nd or 73 rd floor of some highrise to deal in secret with the lives $\&$ jobs of hundreds of thousands of people. It's called North American Free Trade Agreements (NAFTA).

At the rally were reps from labour $\&$ community groups from a few states $\&$ BC \& everything was planned for weeks \& what happens - there's a coup in the Soviet Union! There goes the front page.

Federated Anti-Poverty Groups (fapg) set a date for the Annual General Meeting and Conference last year and what happens a provincial election!

Anyway, it was held in Naramata, about 20 minutes outside Princeton in the Interior, starting on October 16 g going until the 20 th. About 40 people were there, representing over 25 groups \& communities in $B C$, all there to learn $\&$ share $\&$ extend the network of advocacy. Almost any advocate worth her or his salt has more than a
few horror stories about the stupidity $\&$ crude mindsets of bureaucrats - at almost every level of gov't. (Remember, this was at the end of 16 years of socreds..)

Tearing your hair or banging your head against a wall doesn't accomplish much of anything. The executive of fapg know this as well as anyone, $\&$ had very informative speakers/workshops on the agenda.

The first was with Landlord/Tenant Law; updates on GAIN regs $\&$ advocacy training filled the afternoon. The evening workshop with David Mossop of Community Legal Assistance Society was kept strictly within a time limit - the election returns started at 8 p.m. I was relieved not to see people just lose it with ecstasy when Harcourt $\mathcal{q}$ the NDP swamped the socreds. People had learned in the hardest school that hard work brings change, not theatre.

The next day Stephen Owen, BC's Ombudsman, talked about his work \& took detailed notes on problems raised by people. The afternoon was taken partly by the head of Legal Aid for $B C$ talking about the legal area of advocacy; next was an extensive workshop on an issue specifically asked about at the previous year's AGM - child apprehension. Two Native women led this with numbers that made your skin crawl something like over 15,000 Native children taken away from their families in the last 10 years alone. They had a video about one case in particular where a kid of 16 had been in 17 foster homes and 15 trips to a number of institutions - he ended up killing himself. The suicide rate among apprehended kids is sickening.

The advocates \& reps took it in stride, channeling feelings into positive work to stop the excesses, then changing the system altogether. Much informal talk among reps happened all day long on what to do now that the NDP 0 the 'good' guys - were in government.

It was a good time, but on the Saturday night people went to the local pub to relax, one of the reps on her way home was in Merritt at the bus station, came across a young mother whose kids had just been apprehended, called back to this pub at midnight on a Saturday, got two Legal Aid lawyers $\&$ the Head of Legal Aid for $B C$ on
the phone, they gave her numbers of lawyers in Merritt \& Prince George, advised the woman of her rights $\&$ next steps right there, told her what she had to do next to get her kids back as soon as possible then ordered another beer. From what I heard, that was one of the highs of the whole conference, when that kind of networking can be available at any time, any where.

The fapg \& End Legislated Poverty are coalitions whose work is now more focused with a gov't. that is accessible, $\&$ can press on with raising the awareness of the public. Oh yeah, I almost forgot: one re-port established the recent recognition given to low income people as a distinct segment of society under the Charter of Rights \& Freedoms. Yes Virginia! We are now officially visible. As the judge in the FAPG Family Maintenance Enforcement case stated in his ruling, "(we) generally lack substantial political influence \& consequently comprise those groups in society to whose needs $\&$ wishes elected officials have no interest in attending."
No one wants a society that only works for the good of an elite few except those who count themselves as part of that elite. Ordinary people want life to be good for everyone - simply put, for fairness $\mathcal{q}$ justice to be the order of the day.

Rent receipts, three estimates for any clothing or furniture requests, incredible hassles to get funding for education (and even then only getting funding if you choose the sex-stereotyped career they have chosen: auto mechanics for men, and secretarial school for women).... many who need help would rather starve than ask for it.

If the bureaucracy is not too much then there is the ever-present threat of administration; if they think you can't manage on the money you get, they will treat you like a child and dole out your allowonce in weekly installments.

Is it any wonder that many do not appal even flagrantly unjust decisions of the uncaring bureaucracy?


As a now-inactive member of the United Church and a disillusioned believer in the positive role that the church could play in social reform, I am outraged by First United Church's (FUC's) decision to make food aid conditional on appealing the ministry's decision not to give a crisis grant. While some churches give out free food only after a church service (whatever happened to the christian doctrind of free will?), to demand that one appeal before FUC gives out free food is even more dastardly; it makes the victim feel even more victimized and lets them starve until they jump through the bureaucracy's hoops.

FUC claims that this measure will make the ministry more aware of the inadequacy of the system.
